
1. Hear from Public (each speaker limited to 3 minutes);
2. Hear Website Report and take any action thereon, including: (5 minutes)
 - (a) discuss and take action on "Contact Us" questions/comments/concerns; and
3. Hear Constable's Report and take any action thereon, including: (10 minutes);
4. Hear Financial Advisor's Report and take any action thereon, including:
 - (a) review proposed tax rate and related tax calculations;
 - (b) call public hearing on 2019 Tax Rate; and
 - (c) authorize publication of Notice of Public Hearing on 2019 Tax Rate;
5. Hear Tax Assessor/Collector's Report, and take any action thereon, including: (10 minutes);
6. Hear Engineer's Report and take any action thereon, including: (20 minutes)
 - (a) consider approving contracts, pay estimates, and change orders for District projects;
7. Hear Bookkeeper's Report and take any action thereon, including: (10 minutes)
 - (a) consider approving payment of bills; and
 - (b) consider approving Investment Report;
8. Hear Operator's Report, and take any action thereon, including: (10 minutes)
 - (a) consider authorizing repairs to District facilities;
 - (b) consider authorizing maintenance to District facilities;
 - (c) consider approving termination of service to delinquent accounts;
9. Hear President's Report regarding Meadowhill Regional MUD;
10. Consider approving Minutes of meetings held July 23 and August 7, 2019;
11. Hear Attorney's Report and take any action thereon, including:
 - (a) discuss and take action on Normandy Forest HOA questionnaire;
